



## HockeyMania Official Rules - 2023-24

1. No purchase necessary. A purchase will not increase your chances of winning. Sweepstakes begins on 08/15/2023 12:01AM Eastern Time (“ET”) and ends on 04/14/2024 11:59PM ET (“the Sweepstakes Period”). Sponsor observes Daylight Savings Time when applicable. During the Sweepstakes Period, Sponsor calculates winning entry numbers weekly on or about each Monday at 3am ET. Sweepstakes is sponsored and administered by CharityMania, LLC (“Sponsor”). Sponsor is not affiliated with or endorsed by various charitable organizations which may benefit from the Sweepstakes. This is not a raffle, and no purchase is necessary to enter or win. Sponsor is registered in those states that require registration for administration of promotions whose substantial purpose is facilitating fundraising. In order to be eligible for the random winning selection, your entry must be received by the deadline listed below. Note, once you have entered the Sweepstakes, you are automatically eligible for all the drawings that are not yet completed. Your entry must be received before the deadline dates below in order to qualify for that week’s drawing.

No tickets will be available after the cut-off for week 8.

2. Eligibility. The HockeyMania Sweepstakes is open to all legal residents of the United States, excluding U.S. territories, who are 18 years of age and older.

3. How To Enter. In-person entries only. No mail-in or Internet entries. Limit five entries per household address, regardless of number of people living at address. You may enter one of four ways. In-person visit: stop by and purchase a CharityMania Ticket, which contains an access code that allows you to download over \$20 worth of premium digital music, at which time you will receive your promotional sweepstakes game card (“Game Card”) and be automatically entered to win. Event: Attend any charity event sponsored by your local participating Charity, purchase a CharityMania Ticket for \$20.00 and you will receive your Game Card and be automatically entered to win. Solicitation: Door-to-door Charity representatives who are in your neighborhood

will offer you a chance to purchase a CharityMania Ticket for \$20.00, at which time you will be automatically entered to win. Alternate method of entry: Stop by any participating local charity and ask for a free game card request form. Complete the form with all necessary information requested and mail to the address shown on the request form, along with a self-addressed stamped envelope. Your request form must be postmarked on or before the Weekly Deadline date to qualify for that week’s prize. A Game Card will be assigned to you and mailed in the return envelope sent with your form. Even if you do not receive the Game Card before the weekly game for which you qualified, you will still be entered to win. All entrants may enter up to five times, but you may not enter more than one time in a day.

4. How to Play and Selection of Winners. Each Game Card contains 15 randomly generated 3-team combinations (“Team Combination”); total possible combinations: 4,960. Each Team Combination represents one week in the HockeyMania season. At the end of the week, go to [www.charitymania.com](http://www.charitymania.com) to see how many goals each team in your Team Combination received. Each Team Combination’s score is equal to the total number of goals scored by the teams in the Team Combination over the duration of the week. In the event that more than one Team Combination has the same score (i.e. has the same total number of goals scored), then the number of total shots on goal by the Team Combination is used as the primary tiebreaker. The more total shots on goal by the teams in the Team Combination, the higher the value. Please note that higher tiebreaker values are better for the ‘High Score Winners’ and lower tiebreaker values are better for the ‘Low Score Winners’. If two Game Cards are still tied after the primary tiebreaker, then the total number of power plays the teams have on offense is used as a secondary tiebreaker. The more power plays, the higher the tiebreaker value. The persons holding the randomly generated Team Combinations with the top 16 highest scores (after tiebreakers if applicable) are the winners of that week (“Selected Entrants”). In addition, the 4 lowest scoring game cards are also winners (“Selected Entrants”). Although watching and rooting for the teams on your Game Card contributes to the fun of play, it has no statistical effect whatsoever on determining a winner. Team combinations are randomly generated and randomly assigned to Game Card.

5. Notification of Selected Entrants. All Selected Entrants will be notified by email address or phone, and be required to respond (as directed) to the phone and/or e-mail notification within 48 hours of attempted notification. The failure to respond timely to the notification may result in forfeiture of the prize and, in such case, Sponsor may randomly select an alternate chosen entrant from among the remaining eligible entries. Each Selected Entrant may also be sent an affidavit of eligibility / liability release (“Release”). Selected Entrants may also be required to provide name, U.S. Social Security Number (for tax form purposes), birth date, current address and phone number. Unless restricted by law, each Selected Entrant will be required to complete and return the Release within the time period specified therein. An alternate Select-

ed Entrant may be randomly selected from among the remaining eligible entries if a Selected Entrant: (i) cannot be reached; (ii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iii) cannot accept or receive the prize for any reason. Selected Entrants will receive the prize by mail within thirty (30) days of the Sweepstakes end date.

6. **Winner Selection Methodology.** For weekly prizes, Team Combinations are randomly generated prior to the start of the season, using a random number generator. There are a total of 4,960 unique Team Combinations. Each of those Team Combinations is randomly assigned – and distributed -- to a Game Card in groups of 15, prior to the event. Each of the 15 Team Combinations corresponds to one week in the total HockeyMania game. Winners are selected based upon the total goals scored by the Team Combination assigned to the Game Card that week, and not based upon who wins. For Grand Prize: The Game Card with the highest total goals at the end of the HockeyMania game and the Game Card with the lowest total goals at the end of the HockeyMania game will be deemed the Grand Prize Winners.

7. **Prizes.** The following is the distribution of prizes. Each week of the HockeyMania game represents a new, completely independent sweepstakes. The Grand Prize drawing, which takes place at the close of the HockeyMania season represents a new, completely independent sweepstakes. Each Score Card has 302 chances to win. Odds of winning in a single weekly game are 1 in 248 and 1 in 2480 for the grand prize game. Odds of winning at least once during the Sweepstakes Period are 1 in 16.9. Each week, Sponsor will award at least 20 prizes (16 prizes to the holders of the 10 highest scoring Team Combinations, and 4 prizes to the lowest). Each week during the Sweepstakes Period, a pool valued at a minimum of \$975.00 consisting of the following:

- Minimum 1 prize with a value of \$300.00 each
- Minimum 1 prize with a value of \$150.00 each
- Minimum 1 prize with a value of \$75.00 each
- Minimum of 16 prizes with a value of \$25.00 each
- Minimum 1 prize with a value of \$50.00 each

For the Grand Prize drawing:

- Minimum 1 Grand Prize with a value of at least \$500.00
- Minimum 1 Grand Prize with a value of \$200.00 each.

8. **General Conditions.** Sweepstakes is subject to these Official Rules. Sweepstakes may be suspended or cancelled should Sponsor determine that the fair play of the game is being undermined. In the event that the Hockey Season is cancelled, the remaining weekly prizes will be awarded by the random assignment of a score to each Team from 0 - 10, which score shall be posted at the CharityMania website located at <http://www.charitymania.com>. All decisions of Sponsor are final and binding; and entrants agree to waive any right to claim ambiguity in the Sweepstakes or these Official Rules, except where prohibited by law. By accepting a prize, winner agrees to release Sponsor, its attorneys, affiliates, together with the respective directors, employees, officers, licensees, licensors and agents of each, including without limitation, their respective advertising and promotion entities and any person or entity associated with the production, judging, or administration of the Sweepstakes, (collectively, the Releasees) from any and all liability, loss or damage arising from or in connection with awarding, receipt and/or use or misuse of prize or participation in any prize-related activities.

9. **Taxes,** if any, are the sole responsibility of Selected Entrants, and Selected Entrants who are U.S. residents may be issued an IRS Form 1099 for the ARV of any awarded prize. This Sweepstakes is void outside the US and where prohibited or restricted by law, and subject to applicable federal, state provincial and local laws. Sponsor reserves the right to disqualify any entrant it finds to be tampering with the entry process or the operation of the Sweepstakes or violating these Official

Rules. The Releasees shall not be liable for: (i) late, lost, delayed, stolen, misdirected, postage-due, incomplete unreadable, inaccurate, garbled or unintelligible entries, communications or affidavits, regardless of the method of transmission; (ii) telephone system, telephone or computer hardware, software or other technical or computer malfunctions, lost connections, disconnections, delays or transmission errors; (iii) data corruption, theft, destruction, unauthorized access to or alteration of entry or other materials; (iv) any injuries, losses or damages of any kind caused by the prize or resulting from acceptance, possession or use of a prize, or from participation in the Sweepstakes; or (v) any printing, typographical, administrative or technological errors in any materials associated with the Sweepstakes. Sponsor disclaims any liability for damage to any computer system resulting from participating in, or accessing or downloading information in connection with this Sweepstakes, and reserves the right, in their sole discretion, to cancel, modify or suspend the Sweepstakes should a virus, bug, computer problem, unauthorized intervention or other causes beyond Sponsor's control, corrupt the administration, security or proper play of the Sweepstakes. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning prize if, in its sole discretion, it determines such entrant is attempting to undermine the legitimate operation of the Sweepstakes in any way by cheating, hacking, deception, or any other unfair playing practices of intending to annoy, abuse, threaten or harass any other players or Sponsor representatives. Use of any automated system to participate is strictly prohibited and will result in disqualification. Sponsor may disqualify at its sole discretion any entries it believes are created by an automated system. Sponsor may disqualify at its sole discretion any entries it believes exceed the weekly minimum.
